

INSTITUTIONAL ARTICULATION AGREEMENT

**between
Kellogg Community College
and
Olivet College**

Article I

Agreement on Principles

This Articulation Agreement is made on 12/1/18 between Olivet College (OC) and Kellogg Community College (KCC) (collectively, the “Parties”). The Parties wish to facilitate the transitioning for nursing students transferring from OC to KCC and from KCC to OC. Therefore, the Parties agree to enter into an Institutional Articulation Agreement (Agreement) to assist students who want transfer with a smooth curriculum transition that minimizes loss of credit and duplication of coursework.

Article II

Agreement on Program Integrity

The Parties enter into this Agreement as cooperating, equal partners who shall maintain the integrity of their separate programs. Both Parties will maintain their accreditation by the Higher Learning Commission and professional nursing accrediting agency. Let it be known, upon the time of this articulation, it is understood that OC has an application status affiliation with the Commission on Collegiate Nursing Education and a site visit scheduled for September 25-27, 2019. It is expected that full accreditation will occur following the site visit. KCC has received accreditation through the Accreditation Commission for Education in Nursing (ACEN). If accreditation is lost or becomes jeopardized, the college will give written notice to the other college within ten (10) business days of their notification.

Each institution will determine the satisfaction of its program and degree requirements. For the purpose of this Agreement, the Parties agree to accept transferrable courses from each other and from other regionally accredited institutions. Specific course requirements are set forth in Appendix A.

Article III

Agreement on Program Articulation

This Agreement is designed for students who will follow an academic pathway both beginning at OC and transferring to KCC’s nursing program or beginning at KCC and transferring to OC’s RN-BSN Program. Students must also meet all other standard admission, curriculum, and graduation requirements of KCC and OC as described in the academic catalog for each institution.

Article IV

Agreement on Student Advisement and Tracking

OC and KCC have joint responsibility to advise students who follow an articulated academic pathway between the colleges, including advising on admission requirements. Each Party agrees to track the progress and success of articulation participants. Each Party’s responsibility for this tracking rests with the College or Program identified in the applicable Program Agreement.

Article V
Agreement on Financial Aid

There is no corresponding financial aid consortium agreement for the Agreement. Program needs requiring a financial aid consortium will require an addendum to be developed between the financial aid offices of the Parties and those needed to support the program.

Article VI
Agreement on Communication

The Parties agree to cooperate in communicating with each other and with their common and respective publics concerning the established relationship between the two institutions and for the purpose of monitoring and enhancing student academic success. Communication may include the development of various kinds of publications to inform those who might benefit personally or professionally from the opportunities provided through this agreement. Faculty and staff at both institutions will share the information in this agreement with interested and qualified students, and both institutions will provide counseling and advising to students and prospective students.

Any marketing of this Agreement is subject to the prior approval of both parties and must comply with Higher Learning Commission and nursing accrediting agencies' requirements. Each institution will assume responsibility for appropriate marketing to reach their respective student and faculty populations.

The Parties will abide by confidentiality requirements set forth in the Family Education Rights and Privacy Act (FERPA) and other applicable laws.

Article VII
Maintenance and Review Procedures

Responsibility for oversight of this agreement rests with the signatories of the agreement. Both parties agree to communicate annually any changes in their respective program that may affect this Agreement. These changes should be communicated within ten (10) business days, with all changes communicated by January of each calendar year to the respective signatories. This will allow KCC to meet annual catalog deadlines and OC to update its academic catalog and website accordingly. Each institution retains control over its curriculum, course requirements, program requirements and degree requirements. Each institution will notify the other of any curricular changes that would affect the courses in an associated Program Agreement or that could affect the future of this agreement.

Article VIII
Agreement Regarding Independent Relationship

In the performance of their respective duties and obligations under this Agreement, each party is an independent contractor and neither is the agent, employee, or servant of the other, and each is responsible only for its own conduct. Each institution is solely responsible for the development and design of its own curriculum. Changes on the part of either party will/may necessitate review of this document.

Article IX
Notice Provisions

Article X
Agreement Not to Discriminate

Article XI
Entire Agreement

This Agreement is specific to the academic pathways from Olivet College to an Associate of Applied Science in Nursing degree at Kellogg Community College and a pathway to a Bachelor of Science in Nursing degree from Olivet College following a student's completion of an Associate of Applied Science in Nursing degree at Kellogg Community College.


Article XII
Amendment, Modifications, or Termination

No amendment or modification to this Agreement, including any modification or amendment of this paragraph, shall be effective unless the same is in writing and signed by all Parties or their successors. This Agreement will be effective immediately upon authorized signature by each Party and shall remain in effect for five (5) years.


Either Party may terminate this Agreement at any time with no less than sixty (60) days' written notice. In the event that this Agreement is terminated, the Parties shall cooperate to assist currently enrolled students with completing their program.




